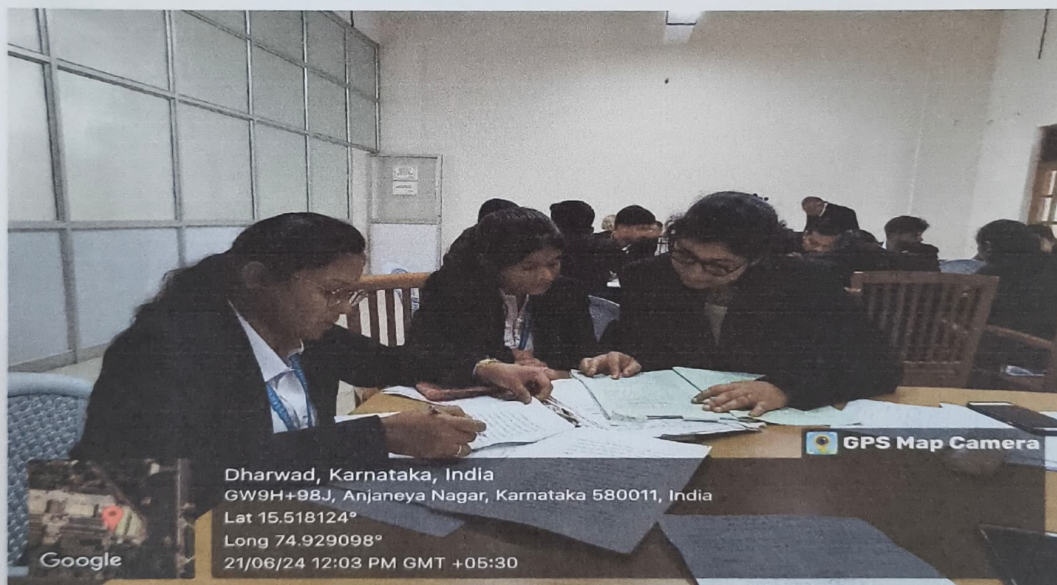

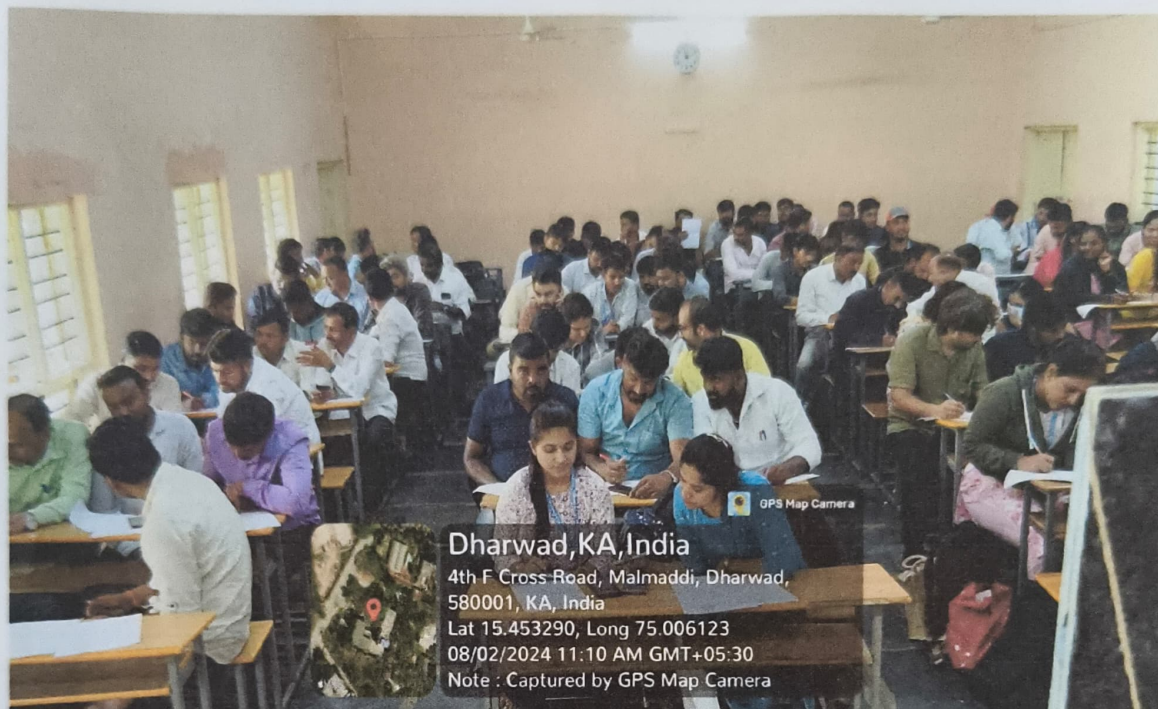

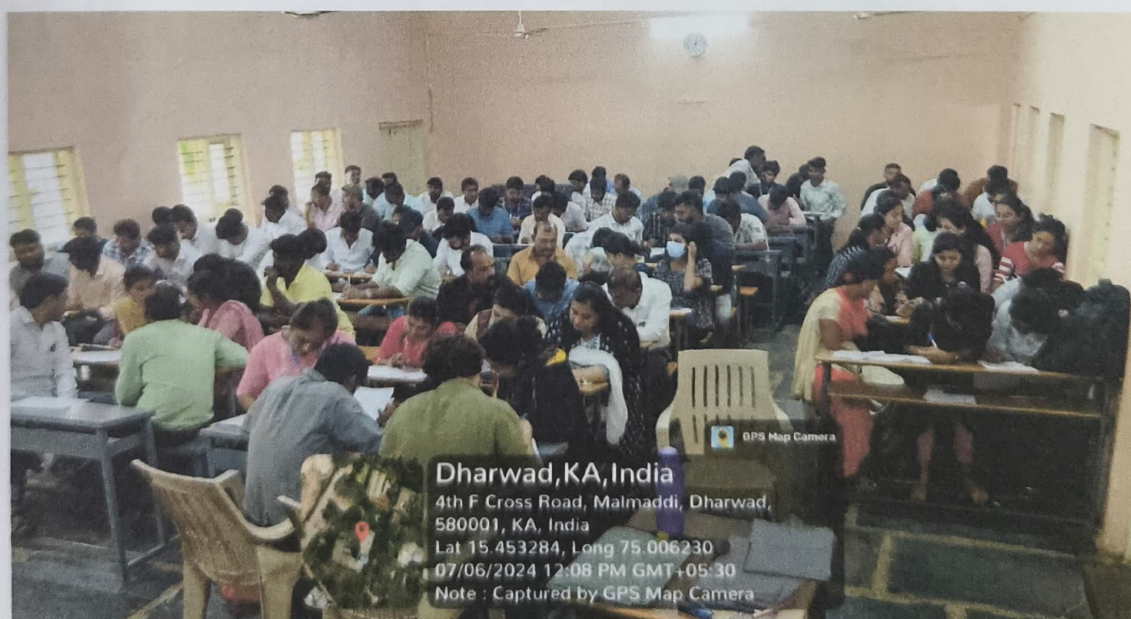


Photo 2: Practical training in ADR simulation exercises

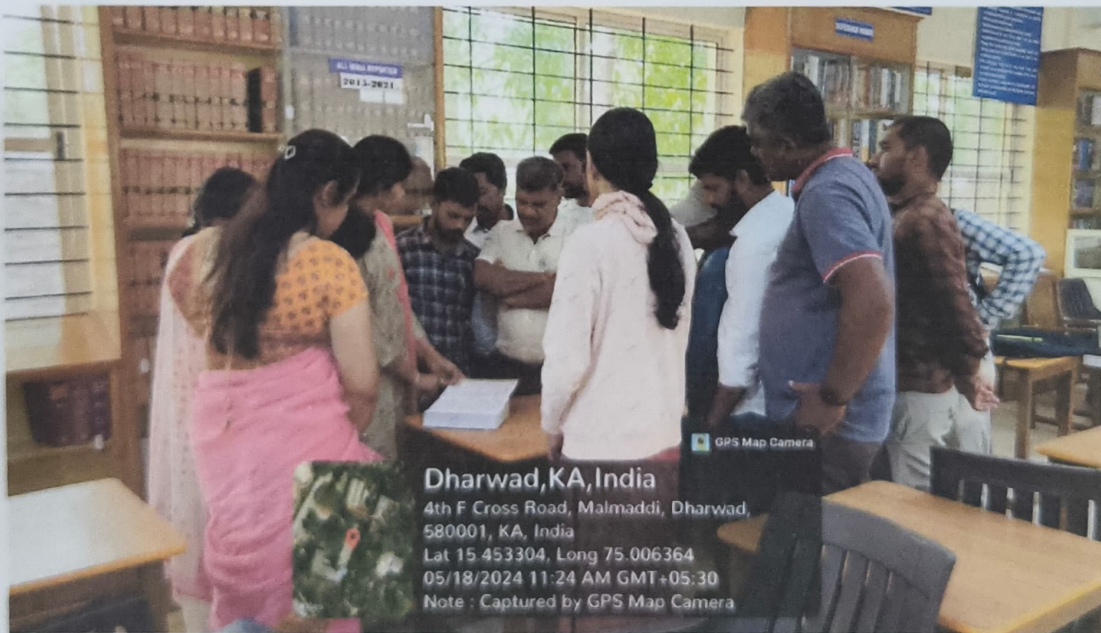
