
The details of the terms of the MOU are as under:

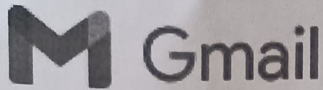
1. Period of the MOU:

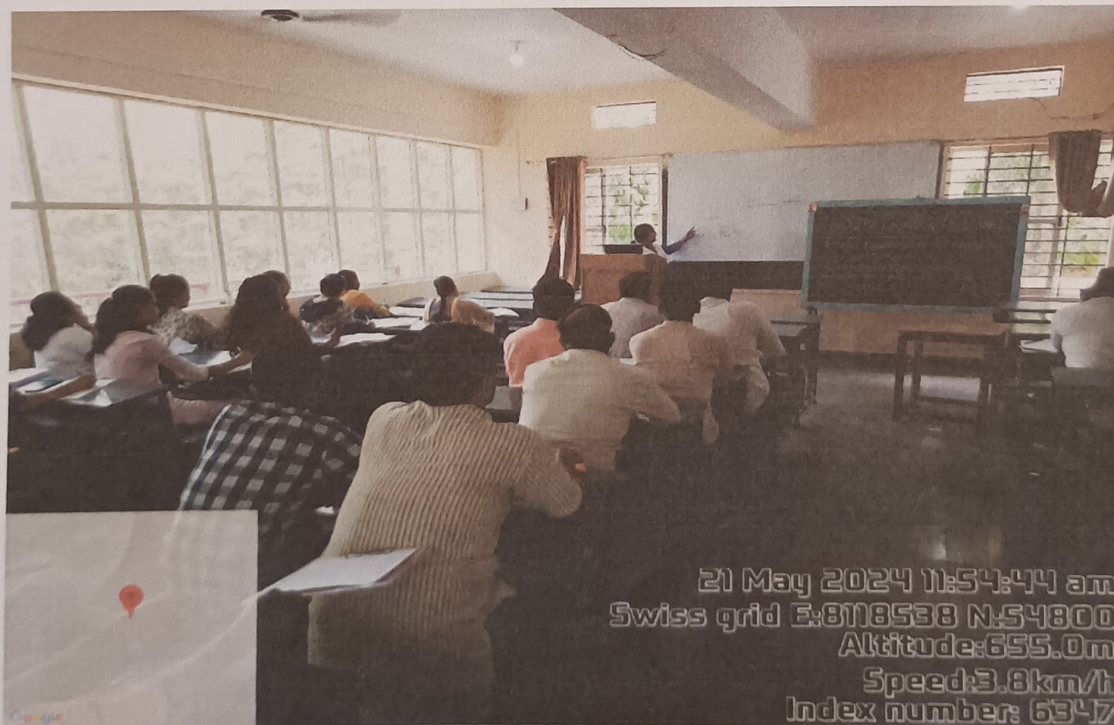
